

### PRODUCT DESCRIPTION

**Functional unit:** Wooden door for indoor use with a honeycomb filling and cover panel with a primer coat. The door meets the requirements of the building code. Fixing materials, hinges and locks are not included. The quantities are calculated back to 1 m<sup>2</sup>.

It is a flush door, meaning the door panel lies completely in the door frame.

The door has an Epicea wooden frame and honeycomb filling and is finished with a prepainted panel with a primer coat.

The door has a service life of 50 years.

CUAS code 32.3.

### DESCRIPTION OF THE MANUFACTURING PROCESS

Raw materials enter the factory in Bekkevoort.

The raw materials are cut to size, most of them have a standard size and do not need to be sawn. The raw materials are prepared in the right order from the predetermined planning.

The wooden frame, the honeycomb filling and the glued cover panels go to the press where the bodies are hot pressed.

The cover panel is prepainted with a primer coat which means that the door is not painted in the factory.

The door is sawn to the correct width and length.

Then the door is provided with the necessary drilling and milling.

In the Theuma factory there is a wood furnace in which the residual wood and wood dust is burned and of which the thermal heat is used for the pressing and heating of the factory.

The calculation is based on data collected from 2019. An average of the annual production is taken. This also applies for the energy consumption.
